## A Message from the Dean

Dear Colleagues,

As of January 28, the work of the VCE restructuring implementation teams has been suspended so that additional input from our internal and external stakeholders can be used to develop a process for considering new restructuring options. Upon the completion of the current General Assembly session, we will ask our partners to be further engaged in this process and to assist us as we define Virginia Cooperative Extension for the future.

We will be seeking your ideas on developing a process to involve all of our various stakeholders. We want to ensure that everyone has an opportunity to ask questions, give feedback, and provide their suggestions. I would encourage you to be an active participant in this process as we move forward.

As previously announced, Dr. Edwin Jones has accepted our offer to serve as associate dean and the director of Virginia Cooperative Extension. He is currently at North Carolina State University where he is associate director and state program leader for agricultural, natural resources, and community and rural development for North Carolina Cooperative Extension. Dr. Jones will begin his role with VCE on April 1, 2011. He is eager to get involved and make a quick transition. In the meantime, I will keep him updated on our progress during this interim period.

Again, I appreciate everyone's patience and involvement as we transition to the next phase of this process.

## State MG Coordinator Liaison Report

- Dr. Grant announced on Thursday, February 10, that Dr. Edwin Jones from NC State will be coming to Blacksburg on April 1 to begin as our VCE Director and Associate Dean.
- It is hoped the 2011 version of the PMG for Home, Grounds and Animals will be available March 1.
- Update on the Department of Horticulture positions:
  - Rhizosphere Biologist: Dr. Mark Williams starts June 1.
  - Tree Fruit specialist: Dr. Gregory Peck starts April 1 in Winchester (Northern Piedmont AREC).
- Landscape/Green Industry: No one from the first round of interviews was hired. More candidate interviews will take place soon.
- The Horticulture Department completed their National Institute for Food and Agriculture (NIFA formerly known as SCREES) review. The review team will be writing up a report and submitting it to us this spring. The Department will offer a response later this summer. Overall, the report was very positive and the dean was pleased.
- MG College planning continues. It is hoped more Master Gardeners will take advantage of this excellent opportunity for continuing and advanced education. Dates are June 21-26. This year's theme is Landcare Stewardship.

## What's Not to Like About Hymenoptera?

Happy spring! Now let me address Hymenoptera, a group of insects that are crucial to maintaining the biological balance in gardens and, by extension, to many farms because they are the key to pollination of vegetables, fruits and flowers. Many "hyms," as they are sometimes called, have an innate ability to recycle nutrients in the soil and they tend to keep in check those insects we sometimes refer to as bad actors. A new book, *Bees, Wasps, and Ants: The Indispensable Role of Hymenoptera in Gardens* (Timber Press, 2010) by Dr. Eric Grissell, while it sounds like a field guide, is actually a valuable resource. Why write a book about bees, wasps, and ants? This is what the author says in his own words. "Although this may seem like hyperbole to some, the goal of this book is to consider the role that Hymenoptera play in the environment and our daily lives, to see if they really are as important as hyperbole suggests, and to provide an introduction to one of the most intriguing insect groups of them all." Dr. Grissell understands the confusion and misconception about hymns and his writing clearly shows not only their relationships to each other, but also their biological position in the natural world.

A hot topic these days is recycling. This effort goes on in the garden too, although often hidden from view. We know the job earthworms do, but do you know that ants are stupendous churners of the soil? As they move organic matter around they are aerating the soil. Meanwhile, other organisms, such as bacteria and fungi, are activated so we end up with humus. Biodiversity, another current topic, will help to stabilize your garden because of complexity of the interaction between organisms. Of course, you can aid this situation by providing the "right kind" of plants that offer moisture (nectar) that will attract insects to your garden. Even a mud puddle will help.

Surely you are aware the use of synthetic pesticides will reduce both prey and host insects, but did you know that organic pesticides (e.g., Bt) are not a cure-all because they kill off hymn hosts? Simply put, insects tend to restore balance in the garden and biological control is an important job that hymns perform. Often these insects have proven to be effective in suppressing other destructive insects that lead, or hopefully lead, to a sort of ecological balance. We need to be realistic about our gardens. Many of us like to attract butterflies into our gardens, but the fact remains bees, predatory wasps, parasitoids, and ants are more beneficial for a garden's health than are butterflies. Lest we forget, butterfly larva will eat plants down to the ground. We also need to develop a healthy respect for hymns. In fact, we need to get over our phobia about insects, especially those that might sting or bite us. You will be amused and amazed by the world occupied by bees, wasps, and ants as you read how Dr. Grissell has uncovered the obscure hymn world. We can gain knowledge and a deeper appreciation of our gardens by bringing nature home and inviting these fascinating creatures into our gardens.
