# STATE MASTER GARDENER COORDINATOR LIAISON REPORT DAVID CLOSE APRIL 9, 2011 CHARLOTTESVILLE, VA

- 1. Dr. Edwin Jones arrived on April 1 to begin as our new VCE Director and Associate Dean. Dave will be meeting with him later in April to discuss the Extension MG program
- 2. 2011 version of Home, Grounds, & Animals PMG is available. Individuals may order them online. If you wish to place a bulk order, your local Extension office should work through Sarah McCoy on campus to process these. Copies for Extension MG Hort Help Desks have been sent out. If your unit has not received theirs yet, they should be in the queue for shipment.
- 3. Dave met with the Director for the Institute for Distance and Distributive Learning to discuss making a portion of the MG training class available online. We will be moving forward with this as an option and hope to have something available by 2012. This will not be designed to replace current models of face-to-face training, but an added option for those who wish to complete at least a portion of their training online.
- 4. Sarah Kelly from the Ag, Human, & Natural Resources Information Technology group (AHNR-IT) from CALS and Dave conducted a one-day training in Charlottesville on Thursday, March 31<sup>st</sup>, on the new Volunteer Management System (VMS). Representatives from 8 units who offered to be pilot locations for testing the system and rolling it out to their volunteers attended. There is still much work to do in

developing training resources, but these 8 units have been given permission to start playing with the system and finding things that need to be modified before it rolls out statewide. It is hoped to the new system will be fully implemented and rolled out by the end of calendar year 2012.

# SEARCH FOR EXCELLENCE-VA (FORMERLY BRAG BOARD COMPETITION) APPLICATION AND RULES

### **Purpose:**

The Virginia Master Gardeners have elected to change the requirements of the former Brag Board competition modeling the program after the International Search for Excellence program. It is the hope of the VMGA-Search for Excellence committee that every VA Master Gardener unit will participate at Master Gardener College and the winners of our VA competition will be entered into the International competition to represent Virginia Master Gardeners.

<u>International Program:</u> The Search for Excellence is the recognition program for Master Gardener Volunteer work throughout the United States and Canada. There are seven categories in which Master Gardeners can demonstrate outstanding contributions to their communities.

The seven categories are:

Youth Programs

**Demonstration Gardens** 

Workshop or Presentation (hands on workshops)

Community Service

Innovative Projects

Special Audiences, Senior / Disabled Audiences or Hort therapy

Other General MG Accomplishments

### **Rules:**

- 1. The projects may cover more than one category, but the group must choose one main category to be considered. The project must have completed one cycle and be worked on over the past two years.
- 2. This is designed to recognize a Master Gardener group project not an individual's project.
- 3. The goal is for the ideas to be simple as to inform and educate other units, to share excellent ideas and programs so they can be replicated by other groups. Step-by-Step "how to do this" is a great way to share your project.
- 4. The program should be easy to use and fit well into the community; show that your group has found the best way to fit the needs of the community.
- 5. Demonstrate the creativity and originality in your project, what has made your group's project your own, show the different personalities of the Master Gardeners in the group.
- 6. These items must be included in the presentation:
  - A: Title of the project
- B: The mission statement of the MG Group, a mission statement of the project team may also be included
  - C: The SLM, which was the focus of the project
- D: A verification letter from the extension Agent / Advisor or Coordination. This letter should indicate that all MG's working on the project were of good standing with their local program.

E: An impact statement. This is a statement and facts about how a person's life or habits were changed as they attended or participated in the event. Surveys can be useful in obtaining information on what the participants have learned. If possible, follow-up post tests are good ways to show the initial level of education and what participants learned and use.

7. The display may contain posters, power point or a computer presentation, back drops with photos. **The Form below must be completed and attached to the presentation.** 

### Scoring;

All entries will be judged during Master Gardener College. Winners will be announced during the annual VMGA meeting. We would like to encourage everyone to prepare a short, 3 minute maximum presentation of their project. Winners will be asked to present their project to the college. Scoring is on a 100-point scale.

### THE GRAINETHUMB

### ENVIRONMENTAL POLICIES: MISUNDERSTANDING, PARANOIA OR GOOD SENSE By George Graine, Fairfax County Master Gardeners

Politics of the environment has become increasingly polarized.
--Jeff Gillman and Eric Heberling

Horticulturalist Jeff Gillman (U. Minn) has done it again! He has written another "truth" book this time co-authored with political science professor Eric Heberlig (UNC-Charlotte) called *How the Government Got In Your Backyard: Superweeds, Frankenfoods, Lawn Wars, and the (Nonpartisan) Truth About Environmental Policies,* (Timber Press, 2011). The many, many points of the book concern whether government policies are helpful or harmful to our society and the environment. There is no simple answer although the authors give it their best shot. Backed up by a 17 page bibliography, each chapter concludes with a five-star right and left-wing rating system indicating an ideal policy (5 stars) to a policy you dislike (2 stars) and even a 1 star that indicates NO for each side of the aisle as we like to say in Washington. The book is wordy but not in a pejorative sense. The authors do not use photos nor do they dazzle you with charts or graphs. None are needed as the policy explanations and evaluations are clearly stated and without hype.

The book quantifies the differences between liberals and conservatives in ten independent chapters about government policies. Aside from these chapters, the stage is set at the beginning of the book with a discussion of the science, political science and the science of politics. The concluding chapter clearly and succinctly notes how balancing nature and politics is important to the discussion. You will not go away with a feeling of paralysis by analysis but rather you will have a greater understanding of how the government got in your backyard. Then, if you are so inclined, you will be able to confront your elected officials concerning policies based on facts rather than the self interest of an individual, corporation or an environmental group.

It is difficult to get around the fact that the greening of America has become the topic du jour and dare I say a contentious one. Politics of our environment have become increasingly polarized. It is apparent from this well researched text that those who are left-wing environmentally-oriented tend to favor strict government regulation of business. Conversely, right-wingers tend to favor inaction, especially when it is not clear that a particular activity causes damage. Of course this is an over simplification as the Gillman-Heberlig book goes into much greater detail concerning the psyche (my word) of left vs. right and "proves" the position of each side by explaining the facts and the science regarding each issue. The authors often provide several choices of policy options and offer possible solutions to each problem presented. Grainethumb has no dog in this fight and believes this book is fair and balanced and without the ever present spin that one can expect from overzealous media. In other words, the authors are not pushing an agenda. They correctly state "With some laws it's immediately obvious that they will have a positive impact, but with others it takes years to discover what the impact will be." "Government policies that deal with our environment almost invariably fall into the latter category." You will be very surprised when you read this book. It may change your mind or you may stick to your guns. Either way, you will become informed, more knowledgeable and be able to separate fiction from fact.
